## *State of Michigan appropriated \$3 million in base operational funding for Michigan's Conservation Districts!*

Great news for Michigan's 75 conservation districts. Thank you Governor Whitmer *and all those who wrote letters in support!*

**Michigan Association of Conservation Districts (MACD) is thrilled to report that due to our advocacy efforts, included in the bill was a \$3 million appropriation for base-line operational support for all 75 of Michigan's Conservation Districts (\$40,000 per district)!**

*Today's passing of SB 82 represents a victory that was years in the making. Since 2009, despite being mandated under state law, Michigan's CDs haven't received a cent in state funding for operational expenses, outside of administrative support for specific grant-based programming.*

Building and installing a bat house can make a difference for bats and help promote a healthy environment.
